

Privacy Statement

Goheen Financial Group, LP is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Goheen Financial Group, LP Website and governs data collection and usage. By using the Goheen Financial Group, LP website, you consent to the data practices described in this statement.

Collection of your Personal Information

Goheen Financial Group, LP collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Goheen Financial Group, LP also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Goheen Financial Group, LP. This information can include: your IP address, browser type, domain names, access times and referring Website addresses. This information is used by Goheen Financial Group, LP for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Goheen Financial Group, LP Website.

Use of your Personal Information

Goheen Financial Group, LP collects and uses your personal information to operate the Goheen Financial Group, LP Website and deliver the services you have requested. Goheen Financial Group, LP also uses your personally identifiable information to inform you of other products or services available from Goheen Financial Group, LP and its affiliates. Goheen Financial Group, LP may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Goheen Financial Group, LP does not sell, rent or lease its customer lists to third parties. Goheen Financial Group, LP may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Goheen Financial Group, LP may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Goheen Financial Group, LP, and they are required to maintain the confidentiality of your information.

Goheen Financial Group, LP does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Goheen Financial Group, LP keeps track of the Websites and pages our customers visit within Goheen Financial Group, LP, in order to determine what Goheen Financial Group, LP services are the most popular. This data is used to deliver customized content and advertising within Goheen Financial Group, LP to customers whose behavior indicates that they are interested in a particular subject area.

What are cookies?

A cookie is a small file created on your computer by a Web server, which can be referenced when that website is visited. Cookies cannot access files or other information stored on your computer. There are two types of cookies: session cookies and persistent cookies. Session cookies are used during a single website visit and are automatically deleted from your computer when you close your browser. Persistent cookies are used to track website activity over a longer period, and remain on your computer until either you choose to delete them or they expire.

Use of Cookies

The Goheen Financial Group, LP Website use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Goheen Financial Group, LP pages, or register with Goheen Financial Group, LP site or services, a cookie helps Goheen Financial Group, LP to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Goheen Financial Group, LP Website, the information you previously provided can be retrieved, so you can easily use the Goheen Financial Group, LP features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you may not be able to fully experience the interactive features of the Goheen Financial Group, LP services or Websites you visit.

Security of your Personal Information
